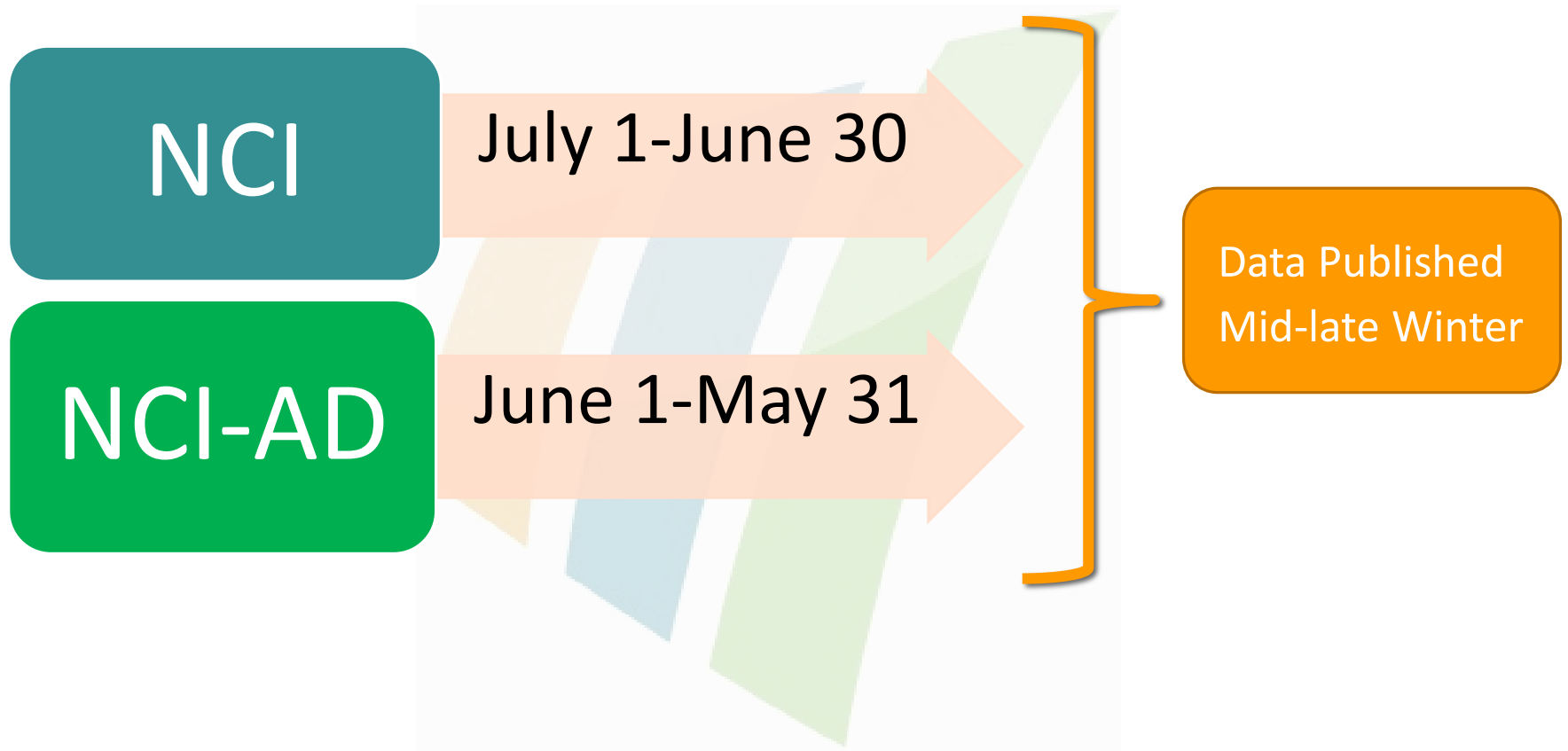

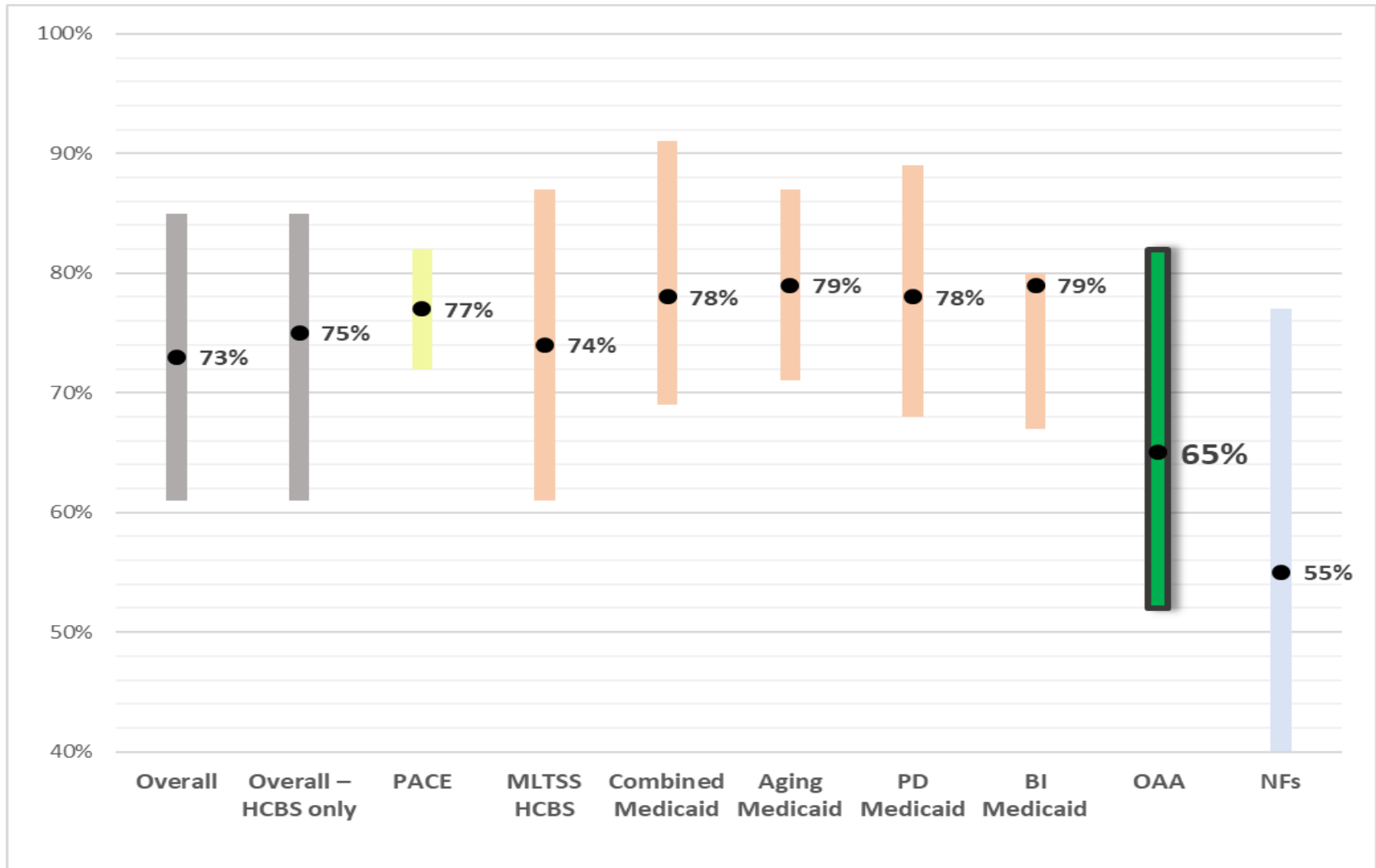

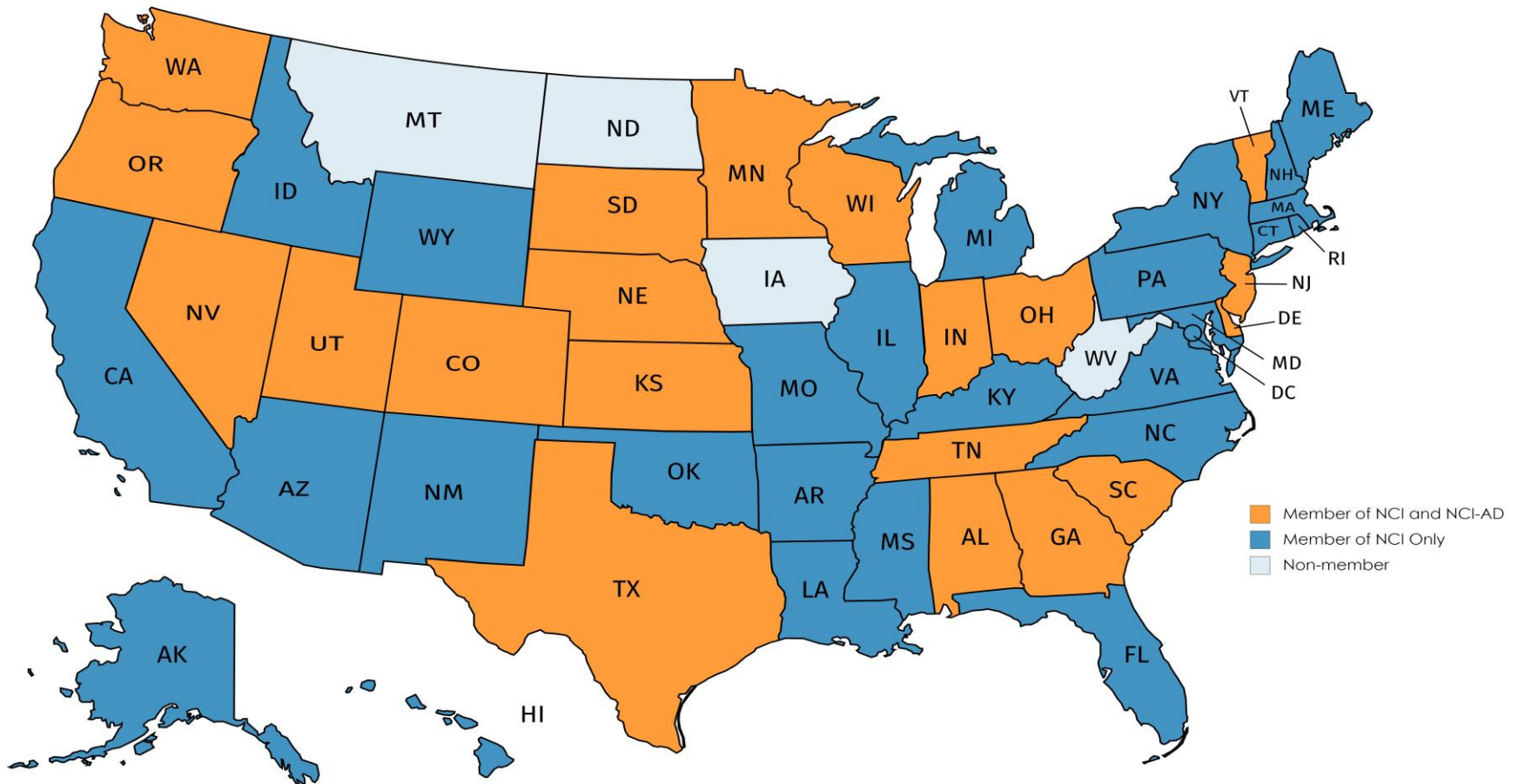
NCI-AD is open to any State Aging, Disability, or Medicaid Agency and new states are welcome to join the project at any time. First year states are encouraged to begin planning for
