
Sharing Results with Stakeholders



Michigan

38,000 individual's with Intellectual and/or developmental disabilities receive services from the Michigan Department of Health and Human Services (MDHHS).

In 2016, 435 of those individuals were randomly selected to complete the NCI survey.



Michigan Considerations for Using NCI Data

- **1. Supported Decision Making**-because of the high rates of guardianship in Michigan, the DD Council developed a Supported Decision Making project to train people around the state to use SDM in the daily lives of people with IDD
- 2. Home and Community Based Servicesdeveloping a crosswalk between NCI and HCBS variables to validate data
- **3. Community of Practice**-analyzing NCI data to inform Michigan's CoP on cultural and linguistic competence in service delivery
